Waiver of Claims

I hereby waive any and all demands, causes of action, lawsuits, or other claims against UDF, CAA, and any of their respective owners, employees, independent contractors, instructors, teachers, assistants, CAA's landlord and all others affiliated with UDF and CAA (hereinafter "Releasees") for physical, emotional, or other injuries or damages to Student, including but not limited to permanent disability, death of Student or damage to property arising out of, whether in whole or in part, the negligent conduct or inaction of Releasees. This Release shall include all demands, causes of action, lawsuits or other claims against Releasees that may be brought by Student or anyone acting on his or her behalf.

Photo/Video Release:

I hereby give permission for images of my child, captured during Utah Dance Festival through video, photo and digital camera, to be used solely for the purposes of Utah Dance Festival promotional material and publications, including Facebook, Instagram and the Utah Dance Festival website and waive any rights of compensation or ownership thereto.

Indemnification
